By booking this event which includes shows, workshops or classes you are accepting the following Terms & Conditions and agreeing to be bound by them and to comply by all applicable laws and regulations.

- Latecomers will only be admitted at the discretion of event management staff and at an appropriate interval.
- Where age restrictions apply staff may ask for proof of ID and refuse entry.
- Under 12s must be accompanied by an adult unless on a specific childrens workshop where this exemption is stated.
- Group bookings involving children under 12 years must include at least one adult for every four children.
- Children under 18 months do not require a ticket unless otherwise stated. They are considered babes in arms and are not allocated a seat however they must be accompanied at all times.
- We reserve the right to refuse admission, even when tickets have been purchased.
- Only food, drinks and alcohol purchased from our bar can be consumed on the premises.
- Inappropriate or dangerous behaviour will result in immediate expulsion from the Landmark Arts Centre.
- We reserve the right to alter events without prior notice. Landmark Arts Centre is not liable to pay any compensation or damages in such instances; this includes and is not limited to tutor or act substitution.
- A booking fee is charged on most bookings which is non refundable
- For select performances, a hidden restoration levy may be included in the ticket price. This fee is dedicated to the upkeep and enhancement of our venue, ensuring that we can continue to provide a high-quality experience.
- We are not liable for any loss, injury or damage sustained within the premises unless due to our negligence.
- We reserve the right to make changes to these Terms & Conditions at any time without prior notice.

Returns and Exchanges

- Tickets are not refundable, unless an event is cancelled or postponed. In the case of the latter than the ticket will still be valid for the new date unless a refund option is chosen.
- If a event is cancelled we will refund via the original payment method only, booking fees and associated costs are non refundable.
- Ticket for events may be returned to the Box Office for resale, if the event is sold out and we have a waiting list we will endeavour to resell the ticket and will issue a credit note if successful. We can't promise to find a buyer for the tickets but we'll do our best. An administration charge of £1.50 per ticket applies and booking fees are non refundable.
- Our ticketing policy operates at the discretion of Landmark Arts Centre management. Please note, these details apply to Landmark Arts Centre programmed shows. Companies hiring the Landmark Arts Centre may operate differently.

- Errors in bookings can be rectified within 48 hours of booking if you have noticed a mistake in booking the wrong dates or event provided the event booked is no less than 7 days in advance. Booking fees are no refundable and an admin fee will be charged. Please contact Landmark Arts Centre as soon as possible at info@landmarkartscentre.org
- Please note events are defined as Leisure Activities by the Consumer Contracts Regulations and are therefore excluded from cancellation rights.

Secure My Booking

- Secure My Booking is unfortunately not available for any classes or workshops run by Landmark Arts Centre.
- Secure My Booking protection is non-refundable in the event of event cancellation.
- Secure My Booking is a per ticket protection item and therefore should be added to match the number of tickets brought i.e. 6 x tickets 6 x Secure My Booking items.
